I. EXECUTIVE SUMMARY

A. Introduction

Audubon Area Community Services, Inc., headquartered in Owensboro, Kentucky, is a 1975 consolidation of two agencies – one based in Henderson, the other in Owensboro – both founded in 1966. In 1975, the agency served the seven-county Green River area and had approximately \$1 million in funding and sixty-five staff members. Currently the agency serves the primary, seven county Green River District, however, Audubon has some program operations in forty-two counties throughout the Commonwealth, including the services areas of Barren River, Cumberland, Pennyrile, Purchase, Lincoln Trail, and Salt River, with over \$55 million in funding and approximately 680 employees.

Audubon Area Community Services is the largest of twenty-three community action agencies serving the residents of Kentucky. Community action agencies are federally designated entities originating from President Johnson's "War on Poverty." As a community action agency, Audubon Area is a private, nonprofit 501(c)(3) corporation governed by a tri-partite, twenty-four-member board of directors consisting of the consumers of agency services, elected public officials, and the private sector - business people, educators, or representatives of local organizations.

In addition to its designation as a community action agency under federal law, Audubon Area Community Services, Inc. is also a Special District of the Commonwealth of Kentucky under KRS 65.005, meaning it is organized for the purpose of performing governmental or other prescribed functions within limited boundaries. In order to also enhance this assessment of needs, as well as meet the requirements set forth by Section 330(k)(2) and Section 330(k)(3)(J) of the PHS Act, staff and board members of with Audubon Area Community Services, Inc. established and jointly enacted a needs assessment in conjunction with the Audubon Area Community Care Clinic, Inc., its staff, and its 13-member independent board of directors to fully assess the social, economic, and health care

determinates impacting needs of the service area landscape, as well as fully present the information for public consumption.

A Comprehensive Community Needs Assessment was conducted from July 1, 2022, through March 16, 2023, by staff of the organization in conjunction with the Community Services Block (CSBG) requirements and as a resource for AACS, and other collaborative partners, to ascertain critical needs in the AACS service area, as identified by community members, consumers, stakeholders, and service providers, to enable AACS to continue adapting programs and services to best meet community needs

A community assessment is a systematic process for creating a profile of the needs and resources of a given community or target population" (Richmond & Mooney, 2012, p. 21). In addition, our funder, the Cabinet for Health and Family Services, Department for Community Based Services, requires the agency to complete a community needs assessment annually.

Section 676(b)(11), of the CSBG Act states "...an assurance that the State will secure from each eligible entity in the State...a community action plan...that includes a community needs assessment for the community served, which may be coordinated with community needs assessments conducted for other programs..." A community needs assessment establishes a profile of a community, noting both needs as well as community resources available. In addition, Section 330(k)(2) and Section 330(k)(3)(J) of the PHS Act; and 42 CFR 51c.104(b)(2-3), 42 CFR 51c.303(k), 42 CFR 56.104(b)(2), 42 CFR 56.104(b)(4), and 42 CFR 56.303(k), requires health centers to annually review its service area of the current or proposed population at least once every three years, for the purposes of informing and improving the delivery of health center services. These factors include access to care and health care utilization; significant causes of morbidity and mortality as well as any associated health disparities; and other unique health care needs or characteristics that impact health status of health care services.

Findings from this assessment will be used to assist Audubon Area Community Services and Care Clinic to continue to deliver high quality services and promote the National Community Action Network Theory of Change Goals:

- Individuals and families with low incomes are stable and achieve economic security.
- Communities where people with low incomes live are healthy and offer economic opportunity.
- People with low incomes are engaged and active in building opportunities in communities.

The current service area has a span of seven counties which include:

Daviess County Hancock County

Henderson County McLean County

Ohio County Union County

Webster County

Audubon Area Community Services offers programming in the larger areas of Community Services, Early Childhood Education, Housing, Transportation, and Employment Services. Note that for purposes of services for Audubon Area Community Care Clinic, the service area includes Daviess, Hancock, Henderson, McLean, Ohio, and Union Counties specifically.

As of March 1, 2023, Audubon Area Community Services has a total of 89 worksite locations across a 46-county service area, employing 685 staff members and impacting the lives of over 40,000 Kentuckians across the Commonwealth as we uphold our mission of:

"Helping people in poverty and beyond to reach self-sufficiency by changing lives through providing services, advocacy, and partnering to strengthen communities throughout Kentucky."

B. Methodology

Multiple sources of quantitative and qualitative data sources were utilized to develop as clear a picture as possible regarding the health, wellbeing, and self-sufficiency of our area. Quantitative data was primarily mined through the CARES Engagement Network platform, an online depository for demographic information from available standardize data resources located at https://cap.engagementnetwork.org. The Community Action Partnership/CARES Engagement Network utilizes sources such as the US Census Bureau (Decennial 2010 and 2020 Census; the American Community Survey 2016-2020 five year estimates), the US Department of Education, National Education Center for Educational Statistics; the US Department of Health and Human Services, Administration for Children and Families; the Department of Health and Human Services Bureau of Primary Health Care; the US Centers for Disease Control and Prevention; US Department of Transportation, US Department of Labor, Bureau of Labor Statistics; the Federal Reserve; and the US Department of Housing and Urban Development. In addition, numerous state, local and agency databases were referenced to gather a clear picture of the demographics of the service area.

Qualitative data was collected in the form of surveys that captured responses from consumers, stakeholders, employees, community leaders, faith-based representatives, elected officials, and board members of the Audubon Area Community Services in the CSBG service area. Surveys were collected between July 1, 2022, and March 1, 2023, in both written and online formats, resulting in 255 reported survey results from the service region. The survey was accessible

online via Survey Monkey via the Audubon Area Community Services, Inc. website, https://www.audubon-area.com/, under the Community Needs Assessment link located at https://www.surveymonkey.com/r/HFGDCZM-CNA, and requested feedback regarding needs of the community, contributing factors to poverty, health care needs, health care access, and areas of focus for growth in programming. Actual results as broken down by county are provided later in this document.

Additional qualitative data was also gathered through the hosting of seven community forum group meetings throughout the region beginning January 26, 2023, through February 28, 2023. A wide range of stakeholders, representatives of each county, and local Audubon Area Community Services staff were invited to attend their county forums. Guided discussions were conducted, and the verbal responses of participants were recorded and later analyzed to discern themes from participants regarding the impacts of poverty, strengths of communities, areas to improve and partners in the community to collaborate. The forums were moderated by Audubon Area staff who guided the attendees through a set of standardized questions: 1) What are some of the greatest needs that low-income persons face in our community? 2) Of the needs identified that we have identified, what do you think are the top 3-5 needs? 3) And, finally, what top three community improvements do you think our agency, or the community should focus on?

The research, analysis, and writing of this Community Needs Assessment were performed under the direction of Brandon Harley, Deputy Chief Executive Officer of Audubon Area Community Services. Community Forum Group meetings were coordinated and conducted under the direction of Angela Ditch, Community Services Manager. Finally, survey data was gathered via a survey located at https://www.surveymonkey.com/r/HFGDCZM-CNA, and maintained by Community Action Kentucky (CAK), a statewide association representing and assisting the 23 community action agencies throughout the Commonwealth. A summary of the assessment area findings will begin on the next page.

Summary of Findings

Quantitative Data Summary findings from sources for aggregate service area:

- 216,185 people live in the 2,597.09 square mile report area defined for this assessment according to the US Census 2016-2020 5-year estimates, an increase of approximately 1% from the service region in the last year (US Census Bureau, American Community Survey. 2016-20).
- > US Census Bureau, ACS (2016-20) indicates that gender breakdown for the area is **49.02**% male, and **50.98**% female.
- The racial breakdown of our service area is comprised as such white population 89.86% of the report area, black population represented 5.23%, 1.03% Asian, 0.14% Native American or Pacific Islander, some other race was 0.99%, and persons identifying themselves as multiple races made up 2.68% of the population (US Census Bureau, American Community Survey. 2016-20).
- > Total population by ethnicity alone estimated that 2.97% was of Hispanic or Latino population, which the remaining 97.03% was Non-Hispanic (US Census Bureau, American Community Survey. 2016-20).
- There are an estimated 85,505 households in the service area (an increase of 114 households from last estimates), while 27,718 or 32.42% were family households with children, (US Census Bureau, American Community Survey. 2016-20).
- 23.57% or 50,960 of our total population in the service area is under the age of 18, 6.29% or 13,594 is under the age of 5 years of age; and 17.38% or 37,583 is over the age of 65 years of age (US Census Bureau, American Community Survey. 2016-20).
- > 16.82% or 35,417 persons in the service area population live at or below 100% of the Federal Poverty Level (FPL). Of those 23.92% or 11,962 are children, while 30.6% or 4,071 of children under the age of 5 live under FPL. In addition, 11.5% or 4,149 persons over age 65, live at or below FPL in the service area (US Census Bureau, American Community Survey. 2016-20).
- Population in Poverty by Gender: 15.45% Male and 18.12% Female (US Census Bureau, American Community Survey. 2016-20).
- Population in Poverty by Race: 15.02% White/Caucasian, 32.76% Black or African American, 8.83% Native American or Alaskan native, 27.81% Asian, 5.97% Native Hawaiian/Pacific Islander, 27.74% "Some Other Race", and 33.62% Multiple Races (US Census Bureau, American Community Survey. 2016-20).
- Population in Poverty by Ethnicity Alone: 39.71% Hispanic/Latino, and 16.12% Not Hispanic/Latino (US Census Bureau, American Community Survey. 2016-20).
- Household Type Poverty Rate: 15.96% of all households were living in poverty within the report area, female headed households represented 49.9% of all households in poverty, compared to 38.6% and 11.4% of households headed by males and married couples, respectively (US Census Bureau, American Community Survey. 2016-20).
- > 55.4% or 19.028 of the students in our services area qualify for free or reduced lunch (National Center for Education Statistics, NCES - Common Core of Data. 2020-21).
- > 15.86% of the population live in an area of the service region with low food access, more than 1 mile (urban) or 10 miles (rural) from a supermarket, grocery store or other food center (US Department of Agriculture, Economic Research Service, USDA Food Access Research Atlas. April 2021).

- > 11.7% or 10,008 households of the service area population receive SNAP Benefits in 2020, while another 7,648 households with income levels below FPL were not receiving benefits (US Census Bureau, American Community Survey. 2016-20).
- 22.98% or 19,649 households in the service area experience a high household cost burden (housing costs exceed 30% of total household income) and 10.49% or 8,973 households are severely cost burdened where housing costs exceed 50% or total household income (US Census Bureau, American Community Survey. 2016-20).
- 23.59% or 20,173 occupied housing units with one or more substandard conditions in the service area (US Census Bureau, American Community Survey, 2016-20).2.24% or 4,865 of the total population in the service area live in group quarters (managed housing situations including college residence halls, residential treatment centers, skillednursing facilities, group homes, military barracks, correctional facilities, and workers' dormitories) (US Census Bureau, American Community Survey. 2016-20).
- > 19.03% or 40,373 individuals in the service area live with a physical, mental, or developmental disability (US Census Bureau, American Community Survey. 2016-20).
- Median household incomes in the service region per county are as follows: Daviess County \$54,881; Hancock County \$56,265; Henderson County \$50,471; McLean County \$54,181; Ohio County \$45,773; Union County \$49,812; and Webster County \$44,540. Kentucky median income is \$52,238 (US Census Bureau, American Community Survey. 2016-20).
- > 5,353 or 6.26% of all households in the services area have no operational motor vehicle (US Census Bureau, American Community Survey. 2016-20).
- The unemployment rate in the area is at 3.7%, an increase of .99% % from last year (US Department of Labor, Bureau of Labor Statistics. 2022 September). 11.8% of the population do not have a high school diploma, while 37.4% have only a high school diploma (US Census Bureau, American Community Survey. 2016-20).
- > 11.3% of the population have obtained at least a bachelor's level degree (US Census Bureau, American Community Survey. 2016-20).
- > **8.85% or 11,016 of adults** in the service area are uninsured (US Census Bureau, Small Area Health Insurance Estimates. 2019).
- > 4.44%, or 2,309 children under age 19 lack health insurance coverage (US Census Bureau, Small Area Health Insurance Estimates. 2019).
- In December 2022, 35.4% or 79,816 individuals are currently qualified for Kentucky Medicaid in the service region (Kentucky Cabinet for Health and Family Services, Division of Administration and Financial Management, Medicaid Statistics, December 2022 Monthly Membership Counts by County, https://chfs.ky.gov/agencies/dms/dafm/Pages/statistics.aspx).
- 48,187 persons were received Medicare benefits in the report area, including 9,940 disabled persons in the report area received Medicare benefits in 2019 (Centers for Medicare and Medicaid Services, CMS Geographic Variation Public Use File. 2019).






COMMUNITY HEALTH NEEDS - Qualitative Survey Results

Community Forum Meeting Feedback

Daviess County:

- Greatest Needs of the low-income: Safe and affordable housing for low-income residents and the growing homeless population; Need for more public and affordable transportation options, particularly in the rural areas of the county; expanded options for mental health and substance abuse service providers in the county; low access to emergency food assistance programming and food deserts in the county; lack of affordable licensed child care providers, particularly for differing times to accommodate shift work.
- Top 3 Needs Identified: Housing and homeless resource options; growth in affordable transpiration services throughout the county and in rural areas; Growth of mental health and substance use disorder resources for all citizens., untreated mental and substance abuse, homeless families need services-access to income and asset building skills and childcare, lack skills to obtain living wage jobs, lack of dentist who accept KY Medicaid
- Top Three Community Improvements to Focus: Community stakeholder meeting to discuss
 growing family homeless shelters and supportive services including current stakeholders,
 elected officials, and community partners; Develop planning session with partners,
 stakeholders and elected officials to discuss potential housing options and project for
 development for elderly and disabled; Work with economic development and elected
 officials to discuss potential for new job growth and growing wages in the private sector.

Hancock County:

- Greatest Needs of the low-income: Safe and affordable housing programs, including repair
 programs for existing housing; Lack of licensed child-care providers available within the
 county; and need for additional income controlled senior housing in the county; additional
 utility assistance programming; dental providers specifically for Medicaid eligible patients;
 and skill and employment training services for adults.
- Top 3 Needs Identified: Safe and affordable housing opportunities/developments; new licensed children care providers within the county; and new senior housing developments for low income and fixed income residents.
- Top Three Community Improvements the Agency Should Focus: Audubon Area and other
 community stakeholders convene a meeting with local county officials to review and possibly
 develop housing options. Publicize the need for new licensed childcare providers and
 processes/benefits of licensing and host a job fair for a childcare workforce. Audubon Area
 host community meetings and share information on the Weatherization program.

Henderson County:

Greatest Needs of the low-income: Lack of safe and appropriate licensed child care providers
in the county; lack of safe and affordable housing options; lack of awareness and
coordination of social support and resource programs throughout the county; Lack of a
family homeless shelter and associated supportive case management services; Growing need
for emergency food resources for the county.

- Top 3 Needs Identified: Lack of licensed childcare providers as well as appropriately vetted
 nontraditional childcare providers; Lack of needed amount of safe and affordable housing
 programs or rental units; Lack of coordination and awareness of social support services
 within the county to support low income.
- Top Three Community Improvements the Agency Should Focus: Coordinate a training for
 promoting child care licensing, training and supportive services; Planning a meeting with the
 Henderson Housing Authority and Audubon Area Community Services to discuss resources
 available and how new projects may develop in the county.

McLean County:

- Greatest Needs of the low-income: Lack of safe and affordable housing options/units within
 the county; Lack of enough living wages jobs to support families in the county; Lack of
 enough transportation options for residents in the county; Lack of coordination and
 awareness of social support programs to assist families and children; lack of providers to
 treat mental health issues and dental health issues; lack of child care providers.
- Top 3 Needs Identified: Safe and affordable housing options; lack of living wage jobs to support citizens; and lack of public transportation services in county
- Top Three Community Improvements the Agency Should Focus: Public coordination and campaign with public and private sector geared toward housing including CDBG funding, education on poverty issues, and community awareness and input meetings; Development of training programs for skill development and job placement especially in rural areas in coordination of a job fair for current employers; and continue growth and exploration of transportation services and options for the county.

Ohio County:

- Greatest Needs of the low-income: Dental health services, especially for Medicaid patients in
 the county; affordable and reliable housing and home repair options; Supportive education
 services to promote better graduation rates; Safe and affordable transportation services;
 Awareness and coordination of supportive programs and services in the county
- Top 3 Needs Identified: Need for dentists and dental health providers for Medicaid patients;
 Safe and affordable housing options and repairs; Higher educational attainment
- Top Three Community Improvements the Agency Should Focus: Assessment of services and funding streams in county to support community to support housing and dental services; coordination of hub for programs and services to support families; Community stakeholder planning meetings to discuss issues and supportive services.

Union County:

 Greatest Needs of the low-income: Affordable and safe child care – licensed and nontraditional; Lack of knowledge of programming to assist residents of the county; Safe and affordable housing options for the low-income; Lack of homeless/emergency shelters in the county for those in most need; Lack of safe and affordable public transportation services.

- Top 3 Needs Identified: Appropriate and affordable licensed child care services within the county; Promotion of assistance programming for those at most need; Safe and affordable rent/lease controlled housing options.
- Top Three Community Improvements the Agency Should Focus: Workshop for potential
 childcare providers to learn more about licensing and training options in partnership with
 existing business; Audubon Area promote a county wide campaign for stakeholders and
 partners to highlight assistance services in a hub/fair environment; Create a workgroup with
 county elected officials and lessors to discuss housing needs and promote accountable and
 explore other leasing/housing options.

Webster County:

- Greatest Needs of the low-income: Lack of safe and affordable housing unit for the low
 income and victims of the county; Lack of affordable transportation options for all county
 citizens; Need for emergency food assistance and reliable access locations; Lack of an
 emergency homeless shelter in the county; Lack of mental health and substance use
 treatment provider.
- Top 3 Needs Identified: Lack of affordable and safe and housing units and repair programs;
 Lack of transportation services throughout the county; Lack of emergency food services and nutrition programs.
- Top Three Community Improvements the Agency Should Focus: Coordinating a group of stakeholders regarding the development housing resources including elected officials and local faith community for new development and housing repair programs; Develop new transportation opportunities through working with current transportation services and local stakeholders including county officials and health care providers; Development of emergency food programs in coordination of Tri-State Food Bank, Audubon Area, St. Vincent de Paul, public schools and Meals on Wheels to meet all county residents.

Themes and Findings

The results of the community needs assessment update for SFY 2023 were categorized into themes which identify needs and issues throughout the community. The key themes are:

• Housing: The most common theme reflected in both survey feedback results (https://www.surveymonkey.com/r/HFGDCZM-CNA) as well as noted in all county forums was the continued and highlighted need for housing for the low-income and fixed income citizens, including seniors and disabled. Housing issues are also reflected in the quantitative data reflecting that 22.98% or 19,649 households in the service area experience a high household cost burden (housing costs exceed 30% of total household income) and 10.49% or 8,973 households are severely cost burdened where housing costs exceed 50% or total household income, and 23.59% or 20,173 occupied housing units with one or more substandard conditions in the service area. In addition, the region has a higher population of

elderly citizens, at 17.38% or 37,583 individuals in the service area. The regional senior population is higher than both state and federal averages and look to continue to grow over the coming years. Local citizens responding to the survey indicated that financial assistant for rent, mortgage, and utilities is a significant need due to the costs of inflation and other monetary stressors. Forum participants verbalized a need for federal financial assistance and the need for grants to make home ownership and home rehabilitation more affordable. Also, respondents noted that programs to increase the amount of available income and senior based housing was in tremendous need in the region. Finally, in many county forum attendees noted an increase in homelessness and the need for tangible assistance for the homeless population was a growing need. Audubon Area Community Services, community, and regional stakeholders, as well as elected officials and citizens will need to focus on development of housing opportunities in the next decade to help offset the trend of housing needs in the region. In addition to this assessment, the recent Community Health Needs Assessment conducted by Owensboro Health and the Green River District Health Department in 2021 (https://www.owensborohealth.org/sites/default/files/documents/ohrh-chna-fullreport-2021.pdf)

indicated that housing was a priority needs as a significant social determinate of health (SDOH) requiring focus and funding to help impact the citizens of its service area.

- Lack of Employment Opportunities: The next highest area of focus as indicated by the data was around employment and related supports. Specifically noted in the survey data were indicators that the region would benefit from higher paying jobs with benefits; competitive wages; and related compensation issues. Also of note, the economy of the region is still struggling to climb out of a period of unease and stagnation, which respondents noted continue to impact families who require adequate living wage employment opportunities 1 to thrive. In reviewing the responses around Employment Needs as a subcategory, respondents noted the need for "more jobs with better pay", "Improve the workforce with readiness skills of people who are able to work", and "Affordable childcare during work hours" as significant barriers commonly expressed. Census data revealed that the unemployment rate has continued to trend down in the service region to 3.7% in September 2022 (US Department of Labor, Bureau of Labor Statistics. 2022 - September) indicating that many eligible individuals are currently in the workforce but may not be making adequate wages to support their households. Focus should be on how to continue to grow employment opportunities that meet the economic and ancillary supportive demands of individuals and families in the region.
- Health Related Concerns and Access to Primary and Preventative Care: Respondents
 consistently in the services area noted a high level of health-related issues in their survey
 responses. Specifically, many respondents continued to note a need for affordable dental
 and hearing assistance, particularly in the areas of dental care, optometry, and hearing
 services. In a review of county health data from Kentucky Health Facts, there are 20.76
 dentists per 100,000 of the population, with only 45 total providers in the seven-county

service area (Centers for Medicare and Medicaid Services, CMS - National Plan and Provider Enumeration System (NPPES). November 2022). In addition, local respondents indicate that a very few providers accept Kentucky Medicaid due to the low reimbursement rates of care, and no active providers accept Medicare, leaving significant portions of the population without local access to dental care in the region. Also, the need for dentists who will serve Medicaid eligible individuals in the service region is a significant need. Additionally, respondents from the survey indicated that locating affordable and accessible primary health care is a continued need within the region. Although the Affordable Care Act (ACA) showed a positive impact in access to care issues survey results yielded a concern in locating a primary health care provider for chronic care management, and more specifically, affordable ongoing primary care providers. Many respondents appear to be turning to urgent care for ongoing health needs and emergent issues. This is a significant issue as it is noted the service area has significant issues with chronic health and preventive health issues including high prevalence of Diabetes, hypertension, obesity, and cancer, which all require engagement with primary health care providers and regular access and check-ups for early detection and treatment.

- Behavioral Health and Substance Use Disorder Treatment: In addition to access issues for primary health care issues, participants in the assessment process noted a heightened need for behavioral health and substance use disorder treatment within the counties of the region. Statistical data shows that the region has access to only 99.63 mental health providers per 100,000 citizens of the service area, well below the 151.60 and 141.85 levels of the state and national levels, respectively (Centers for Medicare and Medicaid Services, CMS National Plan and Provider Enumeration System (NPPES). November 2022). Specifically issues such as medication management for behavioral health disorders, and readily available substance use disorder treatment and recovery inpatient and intensive outpatient services are a high-level need within the region.
- Child Care: A significant issue identified in each county was the need for affordable and stable childcare providers as in the area this area also was a subfactor in the employment issues noted earlier in this assessment. Although unemployment rates are at all-time lows, residents of the region indicate there still is a great deal of tumultuous issues with workforce participation in the region. One high level factor as noted in multiple forums was the lack of safe and licensed child-care providers in counties. The service region has access to a higher-than-normal average of Head Start centers in the region, yet still many children lack total access to safe and age appropriate child care continuously that allow for better education and development for the child, but also more employment opportunities for families.
- Lack of Basic Needs: As noted in the 2021-2022 CNA, and again here in the SFY 2023-2024 assessment, citizens indicated that lack of basic needs continue to impact the lives of residents in the region. Respondents in this assessment period noted a high level of need for necessities like food, clothing, shelter, and other needs, which were also evidenced by the high level of requests for services from AACS this last fiscal year. Audubon Area recorded 30,847 unique assistance applications overall last fiscal year, with well over \$5.5 million dollars of assistance provider in the areas of utility assistance, rental/lease assistance,

supplies, and food assistance requests. This is a continued high level of requests that began during the start of the pandemic and continue up until the date of the authoring of this report.

- Overweight and Obesity Prevalence: Inactivity and poor eating habits continued to be
 negatively impacting the service area as evidenced by quantitative data reviews. Overall, the
 region showed that 69% of citizens of the region report as overweight, which is higher than
 current statewide averages (Centers for Disease Control and Prevention (CDC) and Kentucky
 Department for Public Health. Behavioral Risk Factor Surveillance System Data.
 http://www.kentuckyhealthfacts.org/data. 2016-18). This issue promoted significant health
 concerns such as high prevalence of diabetes, heart disease, stroke, and hypertension issues.
 The Owensboro Health and Green River District Health Department 2021 Community Health
 Needs Assessment also identified this trend as a significant health need impacting the area as
 well.
- Community Focus on Preventative Care: Focus on community health issues and
 programming to educate and coordinate health care initiatives emerged as a significant issue
 of concern. Although respondents noted entities with singular focus, larger coordinated
 efforts to impact community health was found as a need. Educational collaborations and
 community coordinated efforts may help to curtail negative health impacts in the
 community.
- COVID-19 Recovery: As this CHNA is being completed, the area is approximately three-years to the day from the declaration of SARS-CoV-2 (COVID-19) as a worldwide pandemic. As of this writing, the United States has a death toll of 1,123,836. Kentucky has noted 18,177 deaths and the Green River Area has logged 962 deaths in the same period. COVID-19 has been a multifaceted tragedy that has impacted physical health, economic growth, and exacerbated social ills such as poverty level, homelessness, and hunger like no factor in multiple generations. Currently, most of the region is designated as a low COVID-19 level activity and the national emergency and public health emergency declarations are set to end May 11, 2023. The issues impacting the population will continue to be long felt, particularly those impacting the low-income of the service region and therefore, services and benefits to assist areas of employment, housing, health, and emergency services will remain high in the coming years and community stakeholders, community based organizations and health care service providers will continue to have to focus resources on assisting those most impacted for years to come.

Conclusion

The emerging themes of this assessment were not unknown. However, this collaboration of the Audubon Area Community Services and the Audubon Area Community Care Clinic highlighted the impact and connectivity between social issues and health concerns. Better defined as social determinants of health, we come to see how the impacts of income, home, community, employment, housing, and other needs acutely define health and access to health services. These

issues are not born in a vacuum and many times are interdependent and impactive of one another. The findings of this assessment will help guide both entities, as well as, hopefully, other community partners and stakeholders, of issues impacting the citizens of our area. In addition, this assessment will shape strategic and operational plans over the next three period, directing funding and program development to impact the identified issues. Some of the key findings and resulting recommendations extend beyond the mandate and services provided by community action and community health centers and may be of value for other local organizations who share a vision of improving the health and well-being of the community.

a) POPULATION DESCRIPTION AND PROJECTED GROWTH

Total Population

A total of 216,083 people live in the 2,597.32 square mile report area defined for this assessment according to the U.S. Census Bureau American Community Survey 2015-19 5-year estimates. The population density for this area, estimated at 83.19 persons per square mile, is less than the national average population density of 91.93 persons per square mile.

III. COUNTY SPECIFIC INFORMATION

DAVIESS COUNTY

1. BRIEF HISTORY

Daviess County, the 58th county in order of formation, was formed from a part of Ohio County in 1815. It was named in honor of Colonel Joseph Hamilton Daviess, an area landowner and lawyer killed at the Battle of Tippecanoe. The enrolling clerk misspelled the county's name, a mistake later corrected by the General Assembly, but the error continues. The residents were Confederates, and before the Civil War, more than 20 percent of the county's population was slaves. Woodworking industries thrived in heavily timbered areas until the draining of the Panther Creek bottoms in the 1920's.

Nearly half of the population lives in or near Owensboro, the county seat. Today the county is part of the Corn Belt area, where most of the country's corn is grown.

Located completely within the Western Kentucky Coal Field, Daviess County is bordered to the north by the Ohio River, and adjoins Hancock, Ohio, McLean, and Henderson Counties. Its 463 square miles are mostly land used agriculturally.

Hawesville, in the northern part of the county along the Ohio River, has been the county seat since 1829.



1. BRIEF HISTORY

Henderson County is the 38th county in order of formation. It was first settled around 1791. Settlers were initially deterred by Indians and outlaws but were eventually drawn to the area's rich farming land. In the early 1800's, the county seat, Henderson, was made an inspection point for tobacco and other products that shipped out of the region on the neighboring Ohio River. During the Civil War, the county was subjected to Confederate raids and occasional Union occupation.

In the 1930's, before the advent of interstate highways, Henderson County was a stopping point on one of the most heavily-traveled north-south roads. As a result of the tourist traffic, the John James Audubon State Park was established. The namesake county seat of Henderson sits on along the Ohio River on the northern portion of the county.

OHIO COUNTY

1. BRIEF HISTORY

Ohio County is the 35th county in order of formation. The county was established from part of Hardin County on December 17, 1798, and was named for the Ohio River, which formed its northern boundary until Daviess County (1815) and Hancock County (1829) were created from it. Daniel Boone was one of the first explorers in the area. Early pioneers had to contend with attacking Indians, anxious to protect their long-held land. In the 1930's excavations at the Indian Knoll burial mounds yielded over 1,200 skeletons.

River traffic on the Green and Rough rivers is credited with the county's early growth. This was disrupted by the Civil War and virtually ended with the arrival of the railroad in the 1870's.

The economy is a mixture of coal mining, agriculture, and oil. The county seat is Hartford.

UNION COUNTY

1. BRIEF HISTORY

Union County is the 56th county in order of formation. It was formed from part of Henderson County on January 15, 1811, and was probably named for the unanimous agreement of its citizens to create a new county. Morganfield is the county seat. Union County was settled during the westward migration following the Revolutionary War. The county had a considerable slave population prior to the Civil War, and in 1862, Union troops took all residents of Caseyville prisoners on charges of treason. During World War II, more than 1,300 prisoners of war were interned at the Camp Breckinridge Training Center.

The county is the site of numerous Indian burial and ceremonial mounds. After the desecration of more than 1,000 graves in 1987, which prompted the Kentucky General Assembly to make such looting a class D felony, several hundred Indians conducted a reburial service.

Union County is bordered by Henderson, Webster, and Crittenden counties, and to the west by the Ohio River.

Union County covers an area of 343 square miles, ranging from level to hilly. Most of the land is used for agricultural purposes, to which it is well suited.
