Headquartered in Owensboro, Kentucky, Audubon Area is a 1975 consolidation of two agencies - one based in Henderson, the other in Owensboro - both founded in 1966. While serving the primary 7 county Green River Area District (Davies, Hancock, Henderson, McLean, Ohio, Union & Webster counties) Audubon Area also serves Barren River, Cumberland, Pennyriple, Purchase, Lincoln Trail and Salt River areas.

Our Values

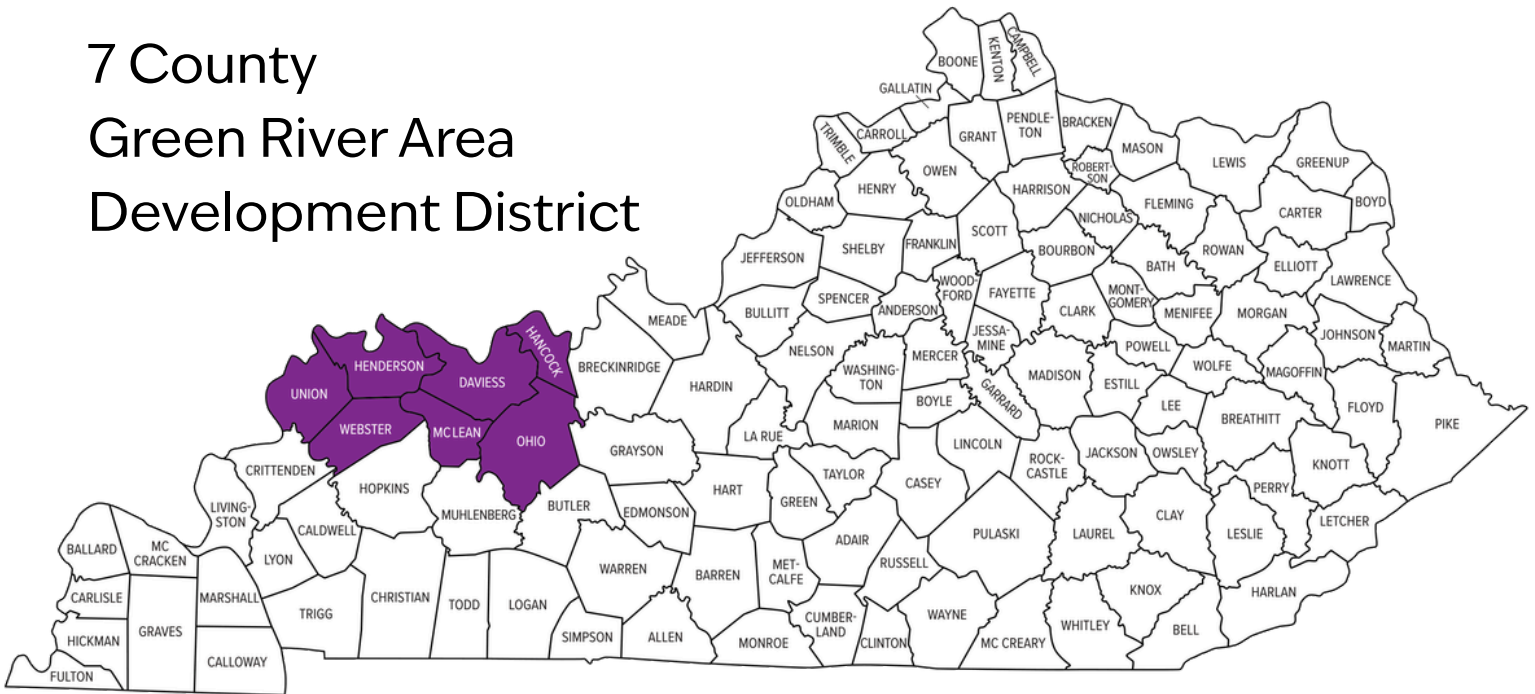

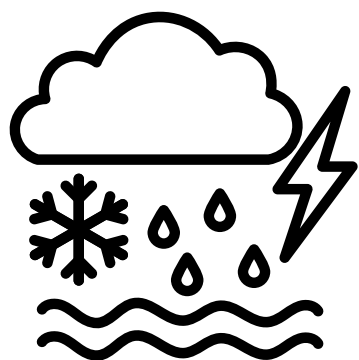
Safe and Affordable Housing

Our Weatherization Program helps qualified Kentuckians save money, increase comfort, and better their homes and environment through proven, energy conservation solutions. Services include

- Energy audits
- Energy conservation education

- LED light bulbs
- High efficiency appliances
- Solar
- Air source heat pumps

Reliable transportation is a vital need for individuals striving to achieve self-sufficiency.

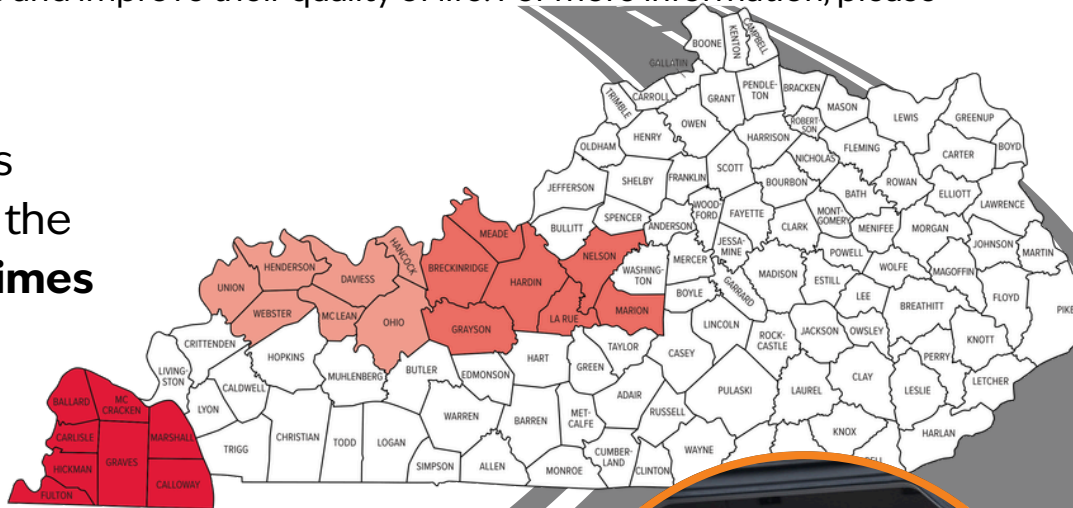
The Green River Intra-county Transit System (GRITS) offers clean, safe, and dependable public transportation at no or low cost. Medicaid-eligible clients without vehicles receive free transportation to approved Medicaid appointments. Additionally, para-transit services and a fee-per-mile service are available to the public.

For over thirty years, GRITS has provided non-emergency transportation covering three regions and 22 counties. We believe that access to reliable transportation is crucial for individuals to reach their goals and improve their quality of life. For more information, please contact your local office.

Community Services

Our Community Services service arm provides a local, trusted place for help in each of our seven GRADD counties. Through these offices, families can access critical support during times of crisis; from emergency food and utility assistance to help obtaining IDs, birth certificates, expungements, and other essential documents. Community Services also includes our Family Preservation and kynect programs, ensuring families can stay safely together, navigate benefits, and access healthcare coverage. When crisis happens, our local Community Services offices are there meeting immediate needs and helping families find stability and a path forward.

Energy Assistance



No one should have to choose between keeping the lights on and meeting other basic needs. Through our energy assistance programs, including the Low-income Home Energy Assistance Program (LIHEAP) and support provided in partnership with other community organizations, we help households manage energy costs and improve home efficiency—offering relief during hard months while supporting long-term stability.

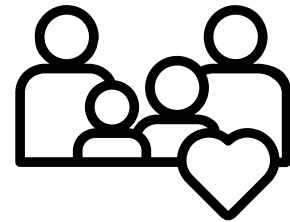

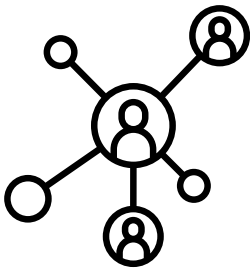


Family Preservation Program

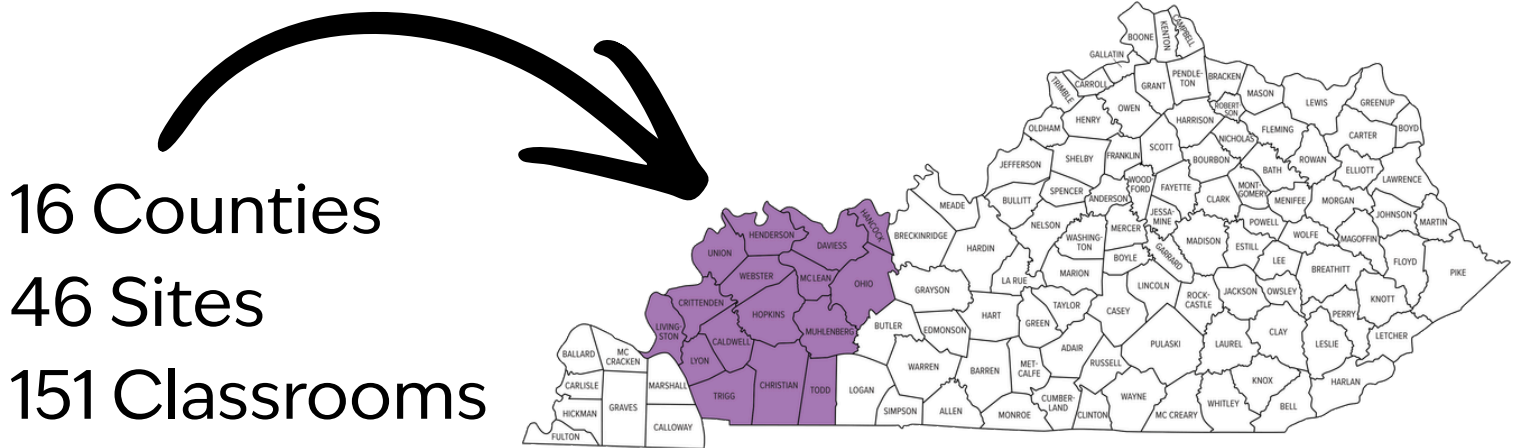

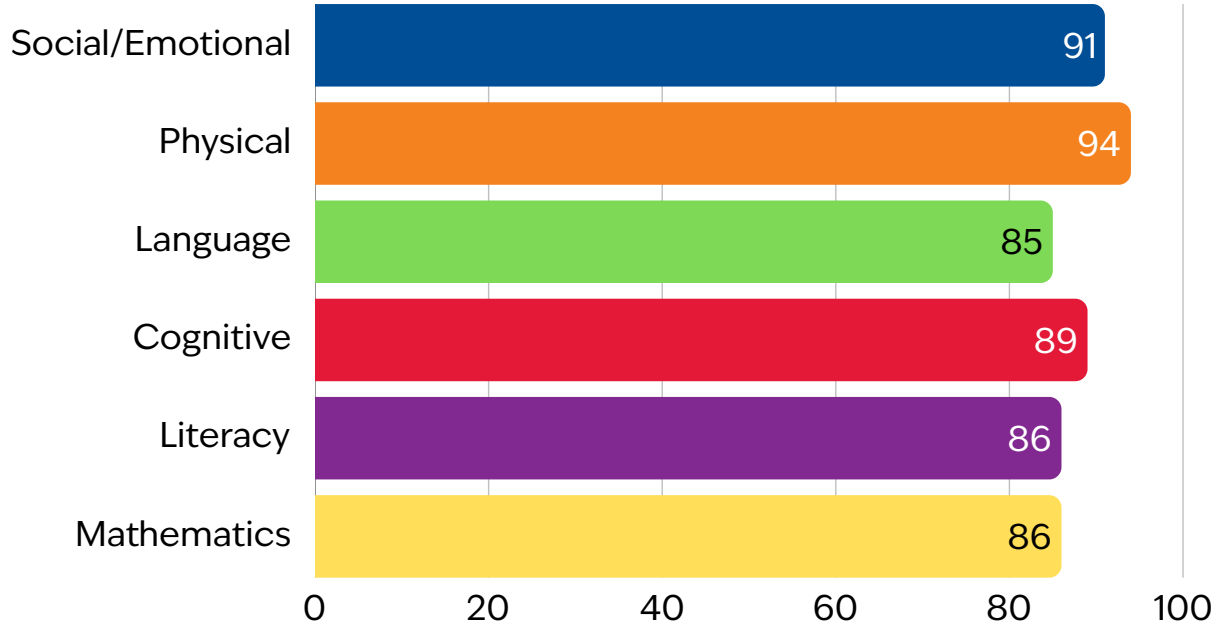
Early Childhood Education

Career Readiness and Volunteerism

Our Career Readiness and Volunteerism service area helps individuals build skills, find meaningful work, and stay engaged in their communities at every stage of life. Through programs like the Kentucky Works Program and SNAP Employment & Training, we support individuals on their path to employment and economic stability. This service area also includes Senior Community Service Employment Program (SCSEP) and AmeriCorps Seniors programs, which provide older adults opportunities to gain job experience, volunteer, and serve their communities strengthening individuals, families, and the region as a whole.



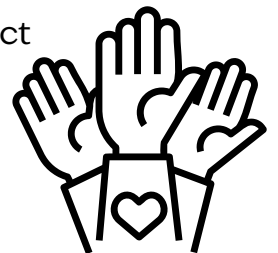

AmeriCorps Seniors

Through AmeriCorps Seniors, our Foster Grandparent Program, Senior Companion Program, and Retired Senior Volunteer Program (RSVP) connect older adults with meaningful ways to serve their communities. Foster Grandparents provide encouragement and support to children in schools and early learning settings, while Senior Companions help older adults maintain independence and remain safely in their homes. RSVP engages seniors in volunteer opportunities that strengthen local organizations and address critical community needs. Together, these programs create powerful connections across generations—benefiting both volunteers and the communities they serve.



The time and talent of our volunteers translated into **\$2,689,169** in value of hours served, strengthening communities across our region.

Health and Recovery



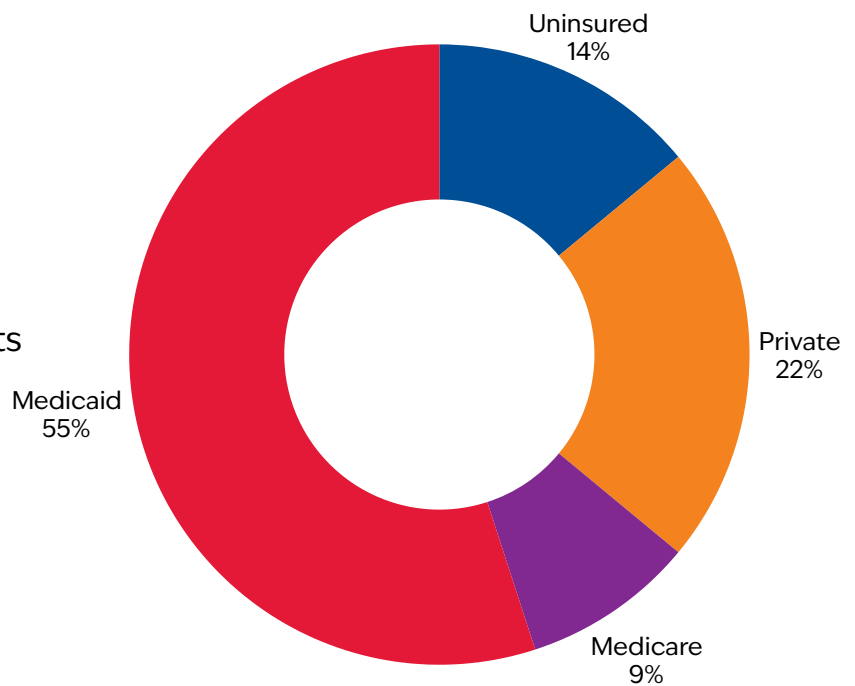
The Audubon Area Community Care Clinic is a vital healthcare resource for our region, providing accessible, comprehensive medical care to individuals and families regardless of insurance status or ability to pay. As a Federally Qualified Health Center, the clinic plays a critical role in strengthening community health—ensuring preventive care, chronic disease management, and integrated services are available close to home for those who need them most.

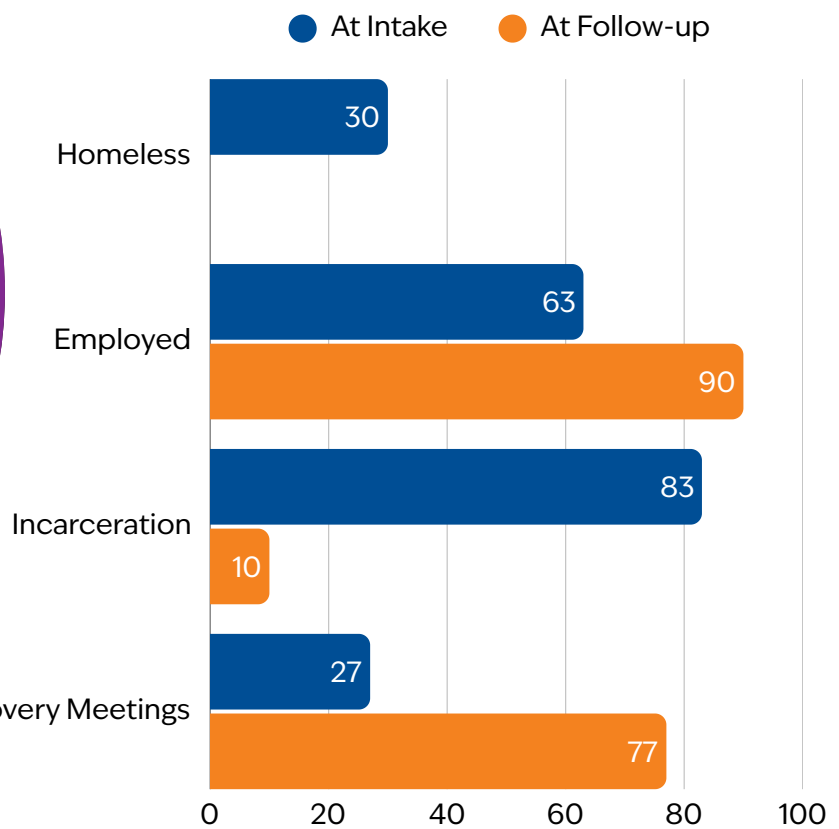
Owensboro Regional Recovery

Owensboro Regional Recovery is a long-term, peer-driven residential recovery program that helps men overcome substance use and rebuild their lives. As part of the Recovery Kentucky network, the program provides a safe, supportive environment where participants focus on sobriety, life skills, employment readiness, and stability laying the foundation for lasting recovery and a healthy return to the community.

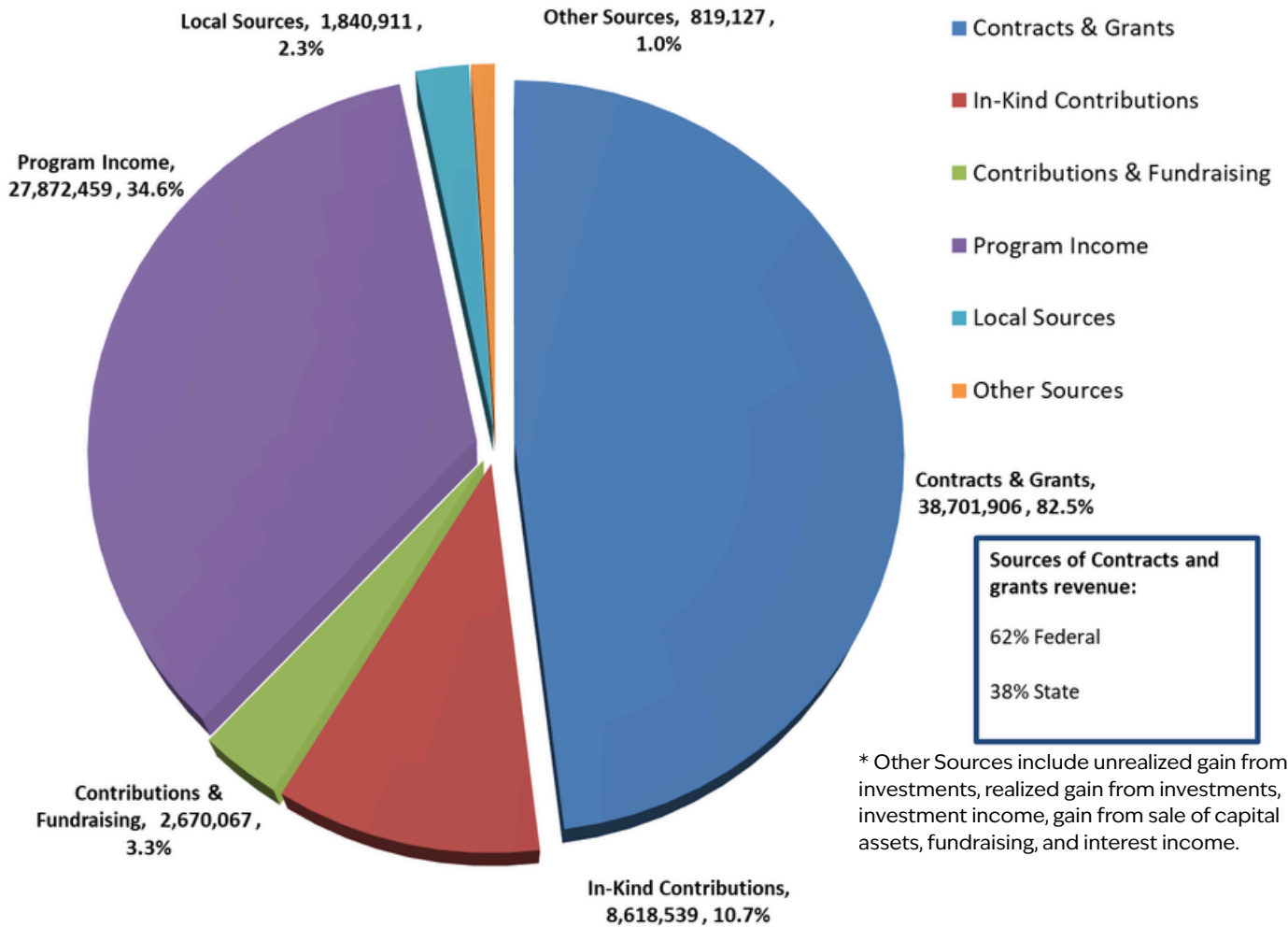

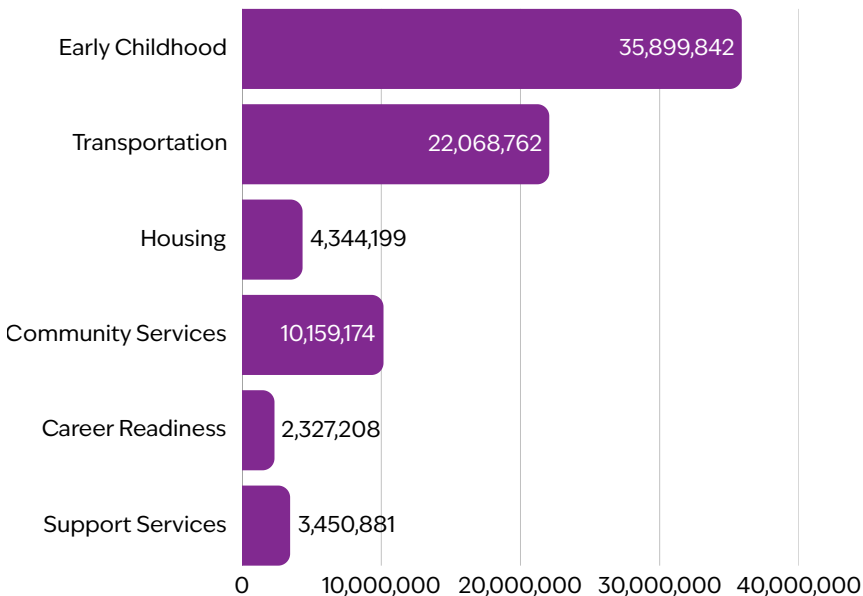

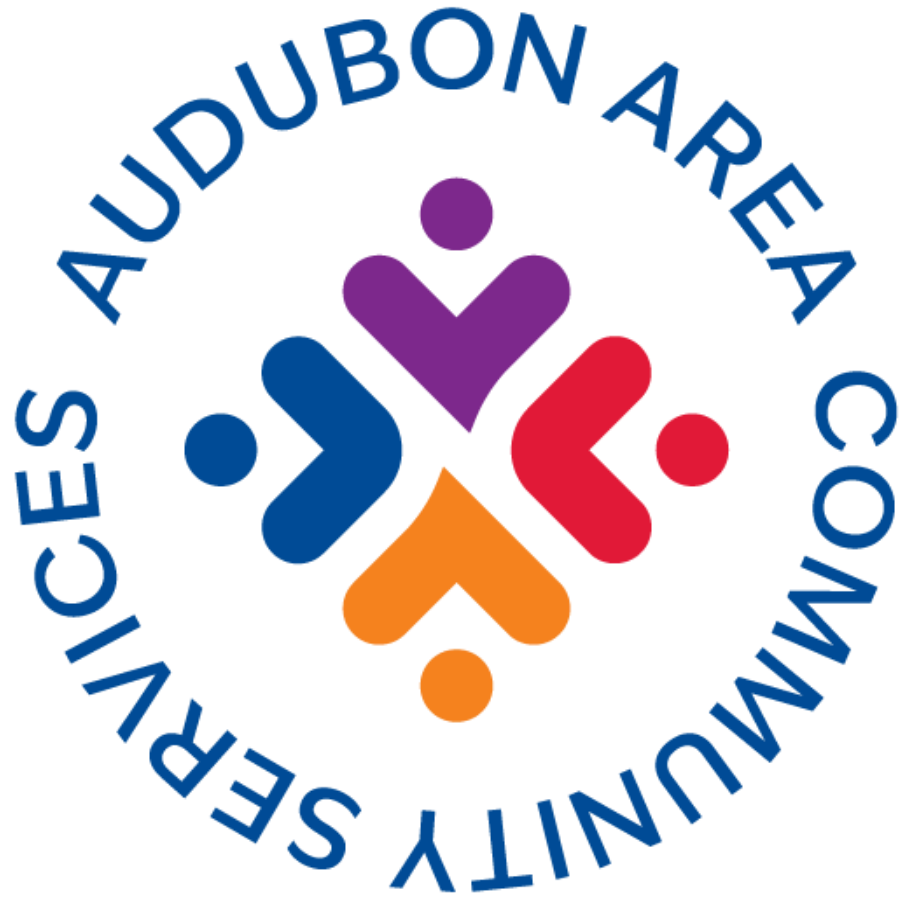
